Historically, one discretionary expense of LPEPC was buying a voter history CD from El Paso County Elections Clerk. This is impacted by LPCO's current policy of sharing their data with affiliates and development groups. LPCO data comes from SoS as well as from the LNC. However, their data does not include local districts that LPEPC has been importing from county data. If we wish to keep the local district data current, we will need to get that information from the county.

Aldo Delgado of PopCode IO performed an update and data import to CiviCRM. This has been long overdue and at last enables LPEPC's database to mostly function, except for bulk emailing, the most valuable feature. Schedule for final repair is unknown.

I have donated some "Join the LP" outreach cards.
